ABSTRACT

A Guide to Water Records of New Mexico, 1897-1983 is a compilation of various types of archival collections, representing a hundred years of water development in New Mexico. The collections include personal papers of individuals and organizations that dealt with the use and study of water in New Mexico. Many areas of the state are represented, including the Isleta Pueblo, Albuquerque, Las Cruces and the Carlsbad region. Thus the water archives represents a broad range of New Mexico's water history.

The collections, now centrally housed at New Mexico State University Archives, are available for researchers. The collections were organized and arranged according to archival standards. To aid researchers in locating documents, a finding aid is available for each collection.

Together these records form a core to base future additions of water records and papers. Therefore, continuing and expanding the availability of information to researchers. Also, these records complement WRRRI Report #190, "A Guide to Elephant Butte Irrigation District Records."

A Guide to Water Records of New Mexico, 1897-1983 serves two purposes. The first is to preserve the records and papers relating to New Mexico's water developments. The second is to provide organized and quickly accessible records and papers to researches.

INTRODUCTION

Justification of Work Performed

A Guide to Water Records of New Mexico, 1897-1983 continued the collecting, processing and preserving of New Mexico water records. Without the formation and continuation of the water archives, many valuable water records and papers would be lost through time and neglect. Through the support of the Water Resources Research Institute, these valuable water records and papers have been stored in a central location and safely housed at the New Mexico State University Archives. These records and papers are now available to researchers, providing the information needed to make future water decisions for New Mexico.

Review of Methodology Used

Standard practices of archival arrangement and storage were employed in organizing, arranging and storing the records and papers collected under the water archives.

The original order of the records and papers, whenever possible, was maintained. In collections where no order was discernible, documents were arranged by types of documents (stock certificates) or by subject (El Vado Dam). The type of arrangement used in a particular collection can be found in the scope and content note and the series description.

Once the collection was organized, the documents were placed in acid free folders and stored in acid free boxes,

thus slowing the deterioration process of the papers. A finding aid was then compiled for each collection. Extensive collections have a finding aid consisting of a historical sketch or biography, a scope and content note, a series description, and a container list, each respectively indicating in greater detail the contents of the collection. Smaller collections containing just a few folders, have a short description outlining the contents of the collection. Arranging the collections in this manner allows researchers quick access to information.

Discussion of Results and their Significance

The records and papers collected under A Guide to Water Records of New Mexico, 1897-1983 cover a broad range of New Mexico water history. The collections are representative of the people and organizations that helped shape water development in the state. Under, A Guide to Water Records of New Mexico, 1897-1983, many valuable and useful collections were assembled. These collections include: Diego Abeita papers; Belen Ditch records; John C. Clark papers; Hagerman Irrigation Company records; Las Cruces Flood Control Project; Mayfield Community Ditch Group records; Middle Rio Grande Conservancy District records; Rio Grande Project records; Pearce C. Rodey papers; Francis G. Tracy papers; Herbert Yeo reports; Zuber Draw Watershed District records. Together these collections contain information that is useful in researching the history of New

Mexico's water development, and providing the opportunity to apply lessons of the past to answer future water questions.

The final significance of these collections is not yet known. Their value will depend upon future water needs and the ability of researchers to interpret the documents found in these collections.

Summary

Each of the collections contain valuable information on water projects, developments and appropriations. Overall the collections present the history of water development from the turn of the century to the present. With more than a hundred years of water records and papers available to researchers the influence of the water archives will extend not only to answering current needs, but will be available to future generations as well.

Chairman of the Middle Rio Grande Pueblos Irrigation Committee, member of the Isleta Pueblo, involved in Indian affairs, rancher. Collection includes correspondence, minutes and resolutions, conference materials, legislation, legal papers, reports, speeches; mostly regarding Indian water use and rights. Correspondents include William Brophy, Clinton P. Anderson, Dennis Chavez, John J. Dempsey, Tom Garrity and A.R. Fife.

Access and Use

OPEN. The files contained in this collection are available for examination in the Search Room.

BIOGRAPHICAL SKETCH

Diego Abeita was born in 1905, his father's name was Louis Abeita. Diego Abeita married Lottie G. Abeita and they had two children, a daughter, Louise and a son, Richard. Deigo Abeita attended the University of New Mexico for about two years in the 1920s. He was self-employed as a rancher, and raised Hereford cattle.

Diego Abeita was very active in Pueblo Indian affairs. He was the first Chairman of the Middle Rio Grande Pueblos Irrigation District, from 1951 to 1977(?). Abeita often acted as spokesperson for the Irrigation Committee. Abeita was a member of the Isleta Pueblo, and served as lieutenant governor for the Pueblo of Isleta. He also served on the Isleta Tribal Pueblo for 30 years and was a trustee of the Bernalillo County Indian Hospital.

Diego Abeita died September 15, 1984.

SCOPE AND CONTENT

The Diego Abeita papers contain correspondence, minutes, conference papers, case files, legal documents, subject files, speeches, reports, clippings, publications and government documents spanning from 1927 to 1981. The bulk of the collection represents Diego Abeita's career as Chairman of the Middle Rio Grande Pueblos Irrigation Committee from 1951 to 1977(?). The main subject area of the collection is Pueblo Indian legal water rights at the state and local levels.

Correspondence is located throughout the collection. A majority of the correspondence is from 1951 to 1977. The correspondence series contains mostly carbon copies of letters sent by Abeita to the various governors of the Middle Rio Grande Pueblos regarding committee business. There are also numerous letters received from New Mexico's Congressmen, Clinton P. Anderson, Dennis Chavez and John J. Dempsey, noting the congressmen's appreciation for serving their Pueblo constituents.

Minutes and resolutions found in the collection are incomplete. The majority of the minutes and resolutions represent the 1950s and the 1970s. During these two time periods, the Pueblos were involved in two cases regarding the distribution of water, Texas v. New Mexico and New Mexico v. Aamodt. The case file series contain court opinions and briefs on these water litigation cases. A

considerable amount of material is devoted in this series on William Veeder's influence, and the Pueblo's assessment of his involvement, in the Pueblo water suits of the 1970s. The Subject files contain a variety of document types. This series covers numerous subjects from grasshopper infestation, 1955-1956, to the Westwide Water Study, 1970-1975. One notable file is the El Vado Dam, which includes resolutions and letters on the storage and release of Pueblo Indian water at the dam.

The emphasis of the Report series and the Speeches, Press Releases, Papers-Others series is on the Pueblo water litigation of the 1970s. Two reports, "Report on the Protection of Pueblo Indian Rights to use Water in the Rio Grande Basin: A Discussion of Pending Litigation" and Comments on Mr. Veeder's Report on Pueblo Water Rights, are of special interest regarding Pueblo water litigation.

The collection includes some personal writings of Diego Abeita, both professional and literary. The Speeches, Press Releases, Poems-Diego Abeita series includes three speeches, a report on Isleta Pueblo Resources and two poems written by Diego Abeita. Also included in the collection are newspaper clippings, publications and government documents. These items cover almost exclusively the Pueblo Indians and their attempts to maintain their water rights.

It should be noted that an archival arrangement was imposed on the Diego Abeita papers. An original order was not discernible when the papers arrived at the Archives.

HISTORICAL SKETCH

Belen Ditch (officially Acequia de Nuestra Senora de Belen), a community owned and operated ditch was constructed in 1905 by farmers in the area between Belen and Isleta, New Mexico, to convey irrigation water from the Rio Grande. The property owners located along the ditch formed an association for the purpose of regulating the distribution of ditch water. It was one of many such small ditch associations formed in New Mexico. Water rights were contingent upon an owner working on the ditch. This usually involved cleaning the ditch and keeping it clear of weeds.

In the 1930s, the Middle Rio Grande Conservancy District (an association of smaller irrigation and reclamation projects) sought to absorb the Belen Ditch. A court finally decided to leave the shareholders in possession of the ditch and its water, but granted the district the right to distribute water to certain non-shareholders below the ditch, in exchange for a fee.

SCOPE AND CONTENT NOTE

Most of La Acequia de Nuestra Senora de Belen (Belen Ditch) records relate either to the cleaning and maintenance of the ditches by the ditch association members, or to the relationship of the association with the Middle Rio Grande Conservancy District which attempted to take over the ditch in the 1930s. Although these records date from 1912-1963, there are many gaps in the existing records. What survives are primarily journals and ledgers containing employee and member accounts. There are some bills and receipts from the 1950s and four folders of election ballots for the same decade. Legal records include court decisions relative to the Belen Ditch and newspaper clippings outlining the Association rules. Among the various record books are a notebook filled with meeting notes, a badly damaged legal writing on New Mexico law, a 1926 certificate book and receipt books from 1924-1926, 1928 and 1949.

SCOPE AND CONTENT NOTE

John W. Clark's papers are basically professional papers, and do not relate Professor Clark's private life. Most of the material contained in the collections are from the 1960s, although there are water samples from as early as 1902, this material is principally research data and does not provide insight in Clark's career. In fact, most of the collection materials relate to water research and use, rather than Clark's role in the field or campus activities.

Biographical information on Clark contained in the collection includes more than a dozen biographical sketches written between 1964-1978. This series also contains certificates of membership in professional organizations and Clark's military records. Clark's student records from the University of Missouri School of Mines and Metallurgy are also contained in this series. The bulk of the material in this series are documents related to Clark's employment at New Mexico State University. Such items include group insurance policies, professional contracts and pamphlets on fringe benefits.

Letters contained in the correspondence series are items that were not filed in specific folders and are general in nature. One folder of correspondence with the American Society for Testing and Materials is also included in this series.

Papers, journals articles, books and reports authored or co-authored by Clark are contained in the Literary Productions series. Included in such files are reprints and printed copies of published works, as well as some typescript manuscript copies of pre-publication work and unpublished materials. There are several copies of Clark's textbook Water Supply and Pollution and a typescript of his other major publication, The Rape of the Waters.

Photographs fall into two distinct categories. Some of the photographs are personal snapshots, while others show research equipment and document specific water conditions. In addition to prints, the photographic series also includes negatives.

The largest series is comprised of printed material. This includes both published and unpublished reports, books, pamphlets, theses, conference programs, clippings and articles used by Clark for reference. Items contained in this series differ from materials contained in the research files in that it was not placed in a specific research folder or applies directly to one of Clark's projects.

Professional activities is the broad term assigned to the series that documents his non-research professional activities. This includes university related functions such as serving on the Campus Appeals Board and the Westhafer Awards Committee. Outside activities of Clark included consulting work with private companies, such as El Paso Natural Gas Company, and public entities, such as Elephant

Butte Irrigation District and the city of Las Cruces. Besides the raw data and final reports for such work, Clark's papers in this series also contain correspondence especially related to these assignments. Clark was also very involved in the work of government water regulatory agencies. Besides the National Water Commission report, this series also contains a synopsis of its proposals and Clark's comments on its work. He also served on the New Mexico Water Quality Control Commission and his files contain agendas, minutes, correspondence and reports generated by the commission water quality hearings. These papers provide the researcher with an excellent overview of official state policy in enactment and enforcement of pollution control during the 1970s.

The research files series contain documents and papers relating to Clark's research interest. Specifically labeled topics include bacteriologic examinations, composite monthly samples, water analysis for both the Rio Grande, Pecos, and Elephant Butte, and monthly weighted means flows and analyses, from the Rubidoux Laboratory in Riverside, California. Clark's abstracts of important works in his field covers 1902-1962 and he also maintained extensive subject files on importation, dissolved solids, Mesilla Valley wells runoff and soil moisture, San Luis Valley Project, and water law.

Finally there are student theses on which Clark served as an advisor or committee member.

INTRODUCTION

Hagerman Irrigation Company
Records, 1904-1983

An irrigation company located in southeast New Mexico, was formed in 1906 and continues in operation. The collection contains the company records; including correspondence, Board of Directors minutes, deed, contracts no. and water rights, quitclaim deeds, stock certificates, water users files, water use records and miscellaneous graphs and maps.

BIOGRAPHICAL SKETCH

The Hagerman Irrigation Company was formed December 29, 1906 as a stock company. Since its creation the Hagerman Irrigation Company has managed and distributed water from the Hagerman Canal, also known as the Northern Canal.

The beginning of the Hagerman Irrigation Company dates back to 1879. When the canal was created by diverting water from the Berrendo Creek, Rio Hondo and South Spring River. The canal is located east of Roswell and extends south of Hagerman. Further development of the canal and the Pecos Valley area was initiated in 1888. Pat Garrett, ex-sheriff of Lincoln County, owned land near Roswell and Charles B. Eddy, a Pecos Valley cattle rancher, began to promote irrigation projects to encourage agricultural development in the Pecos Valley. Eddy soon bought out Garrett and formed the Pecos Irrigation and Investment Co., with Charles W. Green, to develop irrigation in the Pecos Valley. Lacking capital to finance the projects, Eddy met with James John (J.J.) Hagerman of Colorado Springs, Colorado. J.J. Hagerman, a wealthy retired businessman, was intrigued with the prospects of developing the Pecos Valley into an agricultural center. In 1889 Hagerman moved to the Pecos Valley and played an active role in the development of the area. In 1895 J.J. Hagerman and Charles B. Eddy dissolved their partnership and Hagerman became the sole owner of the company.

The Pecos Irrigation and Investment Co. was not a profit making venture. In 1898 the company was placed in a receivership, with Robert Weems Tansill appointed as receiver. The local water users purchased the Northern Canal from J.J. Hagerman in December 1906, and formed the Hagerman Irrigation Company, The canal was then named the Hagerman Canal in honor of J.J. Hagerman.

SCOPE AND CONTENT NOTE

The Hagerman Irrigation Company records provide an overview of a small irrigation company in southeast New Mexico. The records span the years from 1904-1983. The collection was organized into six series.

The first series, Office Files, represents the bulk of the collection. These files are arranged alphabetically by subject. Although this series maintains the original filing system used by the Hagerman Irrigation Company, additional files were created to accommodate loose documents. These newly created files are identified by brackets around the file title. Major portions of this series consist of correspondence; deed, contract no. and water rights certificates; proofs of completion, application for permits; and stock certificates.

The Water User Files are arranged by individual water users. These files are limited, appearing to have been created during the late 1950s and only used through 1961. Although the inclusive dates of this series is from 1949-1971, the majority of the material is from 1958-1961. The Water Users Files contain documents relating to water rights and litigations.

The Ledgers series contains 26 ledgers. Twenty-three ledgers are devoted to water use from 1904-1927. The ledgers contain accounts on individual users of the Company, and the amount of water used on a yearly basis. Also, this

series contains a ledger of the early board minutes (1907-1922), Articles of Incorporation and By-Laws of the Hagerman Irrigation Company.

The final three series, Graphs and Charts, Maps, and Poster represent mostly miscellaneous materials. Of note in the Graphs and Charts series, is a chart of the average flow of the Northern Canal, 1903-1920.

The Mayfield Community Ditch Group records cover a period from May 9, 1984 to October 25, 1985. The Mayfield Ditch users met and organized in 1984. The group established their by-laws and began negotiations with the state engineer to improve the Mayfield Ditch. The improvements on the ditch consisted of lining the ditch with concrete, and the group wanted the state engineer office to help provide financial assistance with the project cost. John C. Nunemaker acted as group representative and worked with the state engineer on behalf of the Mayfield Community Ditch Group.

Within this collection are the documents relating to the formation and completion of the Mayfield Ditch project. These items include minutes of the Mayfield Community Ditch Group meetings, correspondence with the state engineer office, construction cost of the project, land maps of the ditch area, bulletins which provide a progress report to members of the Mayfield Community Ditch Group and photographs detailing construction on the project.

Headquartered in Albuquerque, the Middle Rio Grande Conservancy District serves portions of Sandoval, Bernalillo, Valencia, and Socorro Counties. The minutes begin with the first meeting held on August 27, 1925 and contain an official record of the government of the district.

HISTORICAL SKETCH

There is evidence that the Middle Rio Grande was irrigated in prehistoric times. Agricultural communities diverted water from the river and continued to irrigate their lands during the Spanish, Mexican, and Territorial periods. By the end of the nineteenth century silting and aggradation of the river bed caused serious drainage problems within, led to the deterioration of irrigated lands.

The Middle Rio Grande Conservancy District was established in 1925 as a political subdivision of the state under the Conservancy Act of 1923. Its purpose is to provide and maintain river control and flood protection, improve drainage of seeped areas, furnish water storage, apply supplemental water for irrigation needs, and construct and maintain distribution facilities for irrigation waters. The geographic area served is from Cochiti in the north to San Marcial in the south and includes portions of Sandoval, Bernalillo, Valencia, and Socorro counties. The Indian pueblos of Cochiti, Santa Domingo, San Felipe, Santa Ana, Sandia, and Isleta are within the district. When the district was formed, there were 128,787 acres of irrigable land; by 1980, this figure was about 123,000 acres. The district originally was governed by a three member board of directors; the board since has been increased to five members.

Rodey passed the New Mexico Bar in 1915 and started his practice in Albuquerque with Rodey and Rodey, 1915-27; Rodey and Dailey, 1927-34; Rodey and Dickason, 1934-41. Includes general correspondence, memoranda and legal papers regarding District bond issues, court cases, national and state legislation, taxes, levies and assessments, and other topics. Also includes some MRGCD board minutes and resolutions, newsclippings, reports on agricultural topics and three maps of areas within the District.

BIOGRAPHY

Pearce Coddington Rodey was the son of Bernard Shandon and Minnie (Coddington) Rodey. He was born on November 8, 1889 in Albuquerque, New Mexico.

Pearce Rodey received his preparatory education at Mercersburg Academy, Pennsylvania, 1903-1907 and continued on to Harvard University. At Harvard, Rodey earned his Bachelor of Arts in 1912, and his Bachelor of Law in 1915.

Rodey returned to Albuquerque, to practice law and passed the New Mexico Bar in 1915. Rodey was associated with a variety of firms. These firms include Rodey and Rodey, 1915-27; Rodey and Dailey, 1927-34; Rodey and Dickason, 1934-41; Rodey, Dickason and Sloan, 1941-1958; senior partner, Rodey, Dickason, Sloan, Mims and Akin, 1951-1958.

Pearce Rodey acted as attorney for the Middle Rio Grande Conservancy District, 1925-36; associate counsel for the New Mexico Rio Grande Compact; of counsel for New Mexico Conference of Upper Basin States for Diversion of Water of Colorado River. In 1938 Rodey was the Republican nominee for Congress.

Rodey was married twice. His first wife was Dorothy McMillen. They were married July 1, 1918, and she died March 1932. Pearce and Dorothy Rodey had two children, Shelia (Faust) and Lon McMillen; both were deceased by 1957.

Rodey's second wife was Maria-Elise Johnson. They were married on December 19, 1934. Maria-Elise Rodey died January 1955.

Pearce C. Rodey died May 3, 1958.

SCOPE AND CONTENT

The Pearce C. Rodey papers cover only that portion of his work as attorney for the Middle Rio Grande Conservancy District. These files cover the period from 1926 to 1939; most fall within the period from 1930 to 1935. The main topic was the financial status of the district. One important aspect of this was the sale and repayment of MRGCD bonds for financing district projects. Included are documents relating to the initial sale of bonds, maturity date schedules and the district's inability to pay the full interest rates on bonds in 1937. Some of the major bond companies that worked with the MRGCD are: Reconstruction Finance Corporation; Bosworth, Chanute, Loughridge and Company; and Pershing, Nye, Tallmadge & Bosworth.

Rodey also represented the district in court, involving cases of workmens compensation suits, a claim on wastewater, and a claim brought by bond holders. The papers include court briefs and some evidence and precedents regarding each particular case.

Also included are copies of both proposed national and state legislation of interest to the district. In some cases there is correspondence giving Rodey's interpretations of certain bills.

There are some records concerning taxes and levies of the district. Included, too, are notices documenting the sale of bonds and meetings to discuss district matters.

The files arrived in the Archives in numerical order. This original system was kept, with one exception; the 4000 series folders were filed alphabetically within the 3000 series. Some folder title are followed with " [out]", noting that the contents of these files were not transferred to the Archives.

BIOGRAPHY

Francis Gallatin Tracy was born February 6, 1863, in Bay Ridge, New York. Francis Tracy's father, U.T. Tracy, was a rector of an Episcopal church in New York City, and his grandfather, Uriah Tracy had been a senator from Connecticut. Tracy attended the Cherbuliez' School for boys in New York and St. Paul's School in Concord, New Hampshire. He was a member of the 1884 class at Columbia University.

Following a complete physical breakdown in 1883, he farmed on Long Island from 1884-1889. In 1890 he settled in New Mexico and became involved with the Pecos Irrigation and Improvement Company (P.I.I.C.). He was sent to Roswell by P.I.I.C. and worked there for two years. When Tracy returned to Carlsbad in 1893, he formed a partnership to sell real estate and insurance with Charles McLenathen. In 1895 he became a partner in a hardware store located in Carlsbad.

Although Tracy was active in other pursuits, he still maintained an interest in irrigation. The Pecos Irrigation and Improvement Company was reorganized as the Pecos Water Users Association in 1905. It was in that year that the New Mexico State Legislation authorized the formation of water users association under the Territorial laws of incorporation. It was necessary to form this type of association to be considered for loans available through the U.S. Reclamation Service, for the water users groups

were responsible for the repayment of the construction cost. In 1906 the Pecos Water Users Association entered into a contract with the Reclamation Service for rehabilitation of the Carlsbad project works. Tracy acted as the fiscal agent on the Pecos Water Users Association Carlsbad Project, was President of the Association during the 1920s and was Director of the La Huerta District. At the state level, Tracy served as Chairman of the State Board of Water Commissioners.

Francis G. Tracy was also involved in agriculture development in the Pecos Valley. Tracy was credited with growing the first fruit crop of peaches in eastern New Mexico. In 1898 he shipped three carloads of peaches out of the Pecos Valley. Tracy experimented with growing cotton, and claimed to be the first to attempt growing cotton commercially in New Mexico. In 1902 he grew two acres of Egyptian cotton and introduced the Durango strain of cotton to the Pecos Valley.

Francis G. Tracy married Olive Clark on December 31, 1896 in Carlsbad, NM. They had two children, Josephine and Francis Gallatin Tracy, Jr. Josephine married George G. Eddy, a colonel in the U. S. Army who was the commanding officer at White Sands Proving Ground.

Francis and Olive Tracy were very active in Carlsbad civic affairs. Francis Tracy was active in the Carlsbad Rotary Club, the Carlsbad Commercial Club (later became the Carlsbad Chamber of Commerce), and with his wife, became

charter members of the Carlsbad Archaeological and Historical Society, organized in 1931. Olive Tracy and other women in the community formed in 1924 the Art Appreciation Class. The group participated in correspondence courses from the University of California. The Art Appreciation Class remains active in Carlsbad, and the organization was appointed in charge of the art gallery at the Carlsbad museum.

Francis Gallatin Tracy died January 20, 1951.

SCOPE AND CONTENT NOTE

The Francis G. Tracy papers reflect the diversity of Tracy's interests and business pursuits. The papers span the years 1897-1943, with the bulk of the collection consisting of correspondence. The papers have been organized into twelve series: correspondence, financial, legal, clubs and organizations, insurance, newspaper clippings, printed materials, Public Works Administration, water, miscellaneous, ledgers, and blueprints, maps and sketches.

Correspondence contains both personal and business letters. Of note are the letters written to and from Charles W. Gould in Santa Barbara, California. These letters reflect many of Tracy's personal opinions and also provide insight into his family. Also in this series is a letter from Eleanor Roosevelt.

Many of the series in the collection reflect the business side of Tracy. In the financial and legal series are documents that indicate the many interests that Tracy pursued, and give an accurate account of Tracy's financial status. Statements are included on the Pecos Irrigation Company and Tracy's orchards. The insurance series contains documents relating to individuals and companies that Tracy acted as agent. The water series includes documents relating to the Pecos River, and Tracy's influence on having

the Reclamation Service take over the Carlsbad Project. Within the miscellaneous series are files on selling land in the Pecos Valley and oil and gas ventures.

Two series relate to civic and historical interests of Francis G. Tracy, the clubs and organizations and the Public Works Administration series. Tracy was involved in forming the Rotary Club and the Carlsbad Chamber of Commerce, and with his wife, the Carlsbad Archaeological and Historical Society. These three organizations are represented in the collection. The Public Works Administration series contain brief histories of the Pecos Valley. It appears that Tracy may have acted as director of the project.

The final series, blueprints, maps and sketches contains miscellaneous maps of Carlsbad, the Pecos River and surrounding area.

INTRODUCTION

Zuber Draw Watershed District, 1957-1970
Records, 1955-1971 1.5 feet (1,161 items)

Located at Dexter in Chaves County, the District's purpose was to prevent flood damage to crops, irrigation systems, roads and other properties. Contains correspondence, financial records, legal papers, maps and plats, photographs, and other documentary materials pertaining to the organization's formation, operation, and dissolution.

Access and Use

OPEN. All materials contained in this collection are open for examination by researchers under supervised conditions in the Search Room.

LITERARY RIGHTS. The literary rights possessed in these records by the Zuber Draw Watershed District have been transferred to the Rio Grande Historical Collection of New Mexico State University.

HISTORICAL SKETCH

The Zuber Draw Watershed District in Chaves County, created by a referendum vote on December 14, 1957, became the first watershed district certified under the New Mexico Watershed District Act of 1957. This act enabled sponsoring groups to guarantee their share of costs for watershed projects constructed under the provisions of the U.S. Small Watershed Protection Act. The district was overseen by a board of directors until its dissolution in 1970.

The project was initiated by the Soil-Conservation District of Hagerman and Dexter. Its purpose was to prevent flooding and damage to crops, irrigation systems, and canals and roads. The watershed itself consisted of three washes lying directly west of Dexter. These draws, Thirteen Mile, Zuber and Greenfield, headed approximately 20 miles west of Dexter, flowing east where they fanned out onto cultivated land. There were also four range sites within the watershed project.

SCOPE AND CONTENT NOTE

The files of the Zuber Draw Watershed District span 1955 to 1971. They constitute the records created from the initial planning phase of the project through the district's dissolution in 1970. The records contain minutes of the board of directors, planning documents, including studies, maps, graphs, measured drawings, and correspondence, mostly regarding construction of floodwater regarding structures and land treatment projects on four project range sites, budget materials, employee records, photographs, and other documentary materials related to the work of the District. The files reflect the close cooperation between the Hagerman-Dexter Soil Conservation District and the Zuber Draw Watershed District.

The records are arranged in five small series. The Planning and Formation Series includes field examination reports, applications for assistance, referendum results, petitions, news releases, certifications, and correspondence relating to the formation period from 1955 to 1958 plus files on New Mexico Watershed District Law, land condemnation proceedings, and easements. These materials generally are arranged by date.

Correspondence conducted by the district with various agencies and individuals makes up the second series. These file folders are arranged alphabetically by the name of groups of correspondents. Organization within the folders is chronological.

As improvements of the watershed sites became operational, different types of documents were created. The Operations Series includes inspection reports, employee records, assessment lists, correspondence, and other records related to the District's operational activities. A complete set of board minutes from 1955-1970 also is contained in this series. These files are arranged alphabetically by folder heading and chronologically thereunder.

Materials in the fourth segment, the Site Series, document the bidding process and actual construction of each of four watershed improvement sites. In addition to correspondence, these files contain bid specifications, bid bonds, contracts, bills and receipts, and related records. The files are arranged by site number and type of record thereunder.

Photographs, including color snapshot prints and Polaroid color and black and white prints, include scenes of impounded waters, dams, flood water fences, erosion, and other views. Some are dated October 1965.
